PRESIDENT'S MESSAGE:

On May 17, 2018, the Coconino National Forest Service released

its revised and final Land and Resource Management Plan. This plan replaces the 1987 Plan and is the result of years of collaboration between the Forest Service and many interested parties. Keep Sedona Beautiful was one of the key contributors to the current plan.

When I first joined the KSB board in early 2014, I was asked to be part of a team to review and comment on the roughly 2000 pages of documents comprising the proposed plan. We worked diligently within a tight time frame to analyze the plan, and provided the Forest Service with almost 60 pages of comments and suggestions to improve it. In addition, KSB met several times with the Forest Service team drafting the plan in order to explain our concerns and suggest improvements.

I am pleased to report that the final Land and Resource Management Plan just released retains key portions of the 1987 Plan that protect this national forest. In particular, the safeguards of Amendment 12 to the 1987 Plan (notably restricting land trades) have been kept in the current version.


Another aspect of the forest plan and

Amendment 12 that is frequently overlooked is the commitment to quiet. As the Forest Service noted: Natural quiet is a value inherent to National Forest lands. The loss of natural quiet has been identified as one of the most significant issues for the Sedona/Oak Creek ecosystem. As one enjoys the forest and especially the wilderness areas, there is an expectation that part of that enjoyment will be the opportunity to be in the forest in relative solitude. Keeping that as a goal for the forest plan is a key component.

Thus, I am proud of the leadership that KSB has shown in this process. We have worked with the Forest Service and urged it to enact a plan that continues to protect this area so that the forest and the quiet can be enjoyed by generations to come.

"KSB has been protecting our environment since 1972. In addition to running the Litter Lifters and protecting our Dark Sky, they also walk the talk. They have preserved an historic building and repurposed materials (like giving Gardens for Humanity their old decking.) They teach the local community about how to save water and build habitat at the annual Native Plant Workshop; (this year was their 39th conference). They're planning to upgrade the energy efficiency of their building and already buy all green power from APS."

39TH ANNUAL NATIVE PLANT WORKSHOP



The 39th Annual Native Plant Workshop had over 120 participants listening to the keynote speakers. Hattie Braun spoke on how to Unleash Your Garden's Wild Side: Garden Design Using Native Plants, and Director/Filmmaker Hugh Denno showed his movie VIVA LA VERDE! Breakout sessions covered topics from Monarch Waystations (Denise Gibbs), Xeriscaping (Jason Lavelle), Landscaping to Attract Birds (Eric Moore) to Lichens 101 (Garry Neil) and Environmentally Friendly Pest Management (Jeff Schalau). Max Licher led a nature walk explaining the uses of native plants.

Food was supplied by Wildflower Bread Company, Bashas and the Snyder's, with water stations on loan from Kinetico. Many attendees helped make this a more sustainable event by bringing their own mugs and water bottles.

We had a variety of plant related items donated by the community for our Silent Auction which brought in over \$1500. We thank our donors for their support.

This year the 12th Herkenham recipient was Hattie Braun, a past speaker at the NPW and currently the Director for the Coconino Cooperative Extension in Flagstaff. This award goes to individuals, businesses or organizations that further the education and implementation of native plant landscaping.

TRAIL KEEPERS LOOKS TO EXPAND



SPEAKERS SERIES - SAVE THE DATES!




The Speakers Series resumes on its usual second Wednesday of the month, on September 12th, with photographer Ted Grussing sharing his amazing photographs of our natural environment, with emphasis on the beauty of our dark skies.

On Wednesday, October 10, Nicole Branton, Red Rock District Ranger, will provide an update on the US Forest Service Red Rocks District.

Janeen Trevillyan, Historian of the Sedona Heritage Museum will be our speaker on Wednesday, November 14. Janeen's presentation is titled, "Sedona's Architectural Past—A Trip by Time Machine."

These events are held at 5:30 p.m. at the KSB Pushmataha Center, 360 Brewer Road, Sedona. Appetizers will be provided by El Rincon Restaurante Mexicano and beverages will be served. Admission is free and open to the public, although donations are appreciated. Speaker Series guests may sign up for membership in KSB at these events.





FIRE SEASON IS UPON US

While fire is an ever-present threat in Northern Arizona, this year that danger is particularly acute. The 2017 monsoon season ended early, and we had a particularly dry winter and spring. The dry weather continues, making conditions ripe for fire.

The Forest Service has already closed the Fossil Creek area temporarily, invoking Stage 3 fire restrictions. If we don't get some rain in the near future, more Stage 3 restrictions may be put in place, closing even more of the forest from use. Stage 2 restrictions are in effect for the remainder of the Coconino National Forest.

Outside the forest, the Sedona Fire District has put their own Stage 3 fire restrictions into effect for the entire district regardless of whether those areas are within Yavapai or Coconino counties.

We all need to do our part in protecting and preserving Sedona by following these mandated restrictions. Open fires are not allowed, nor is shooting of any firearms. Smoking outside of enclosed vehicles or buildings is prohibited.

Use common sense to avoid causing a problem and report any problems that you see. If you come across a smoldering campfire or any sort of active fire, you should call 911 immediately.



?FIKE STRICTIONS

THE FOLLOWING IS PROHIBITED ACROSS THE ENTIRE FOREST, INCLUDING CAMPGROUNDS:



- Fires, campfires, charcoal, coal, and wood stoves.
 (except using a device that is solely fueled by liquid petroleum or LPG fuels that can be turned on and off in areas that are barren or cleared of all overhead and surrounding flammable materials within three feet of the device).
- 2. Smoking (except within an enclosed vehicle or building).




4. Possessing, discharging, or using any type of firework by pyrotechnic device.





3. Using an explosive.









The national forests use fire restrictions to help prevent unwanted, human-caused fires and to limit the exposure of visitors during periods of potentially dangerous fire conditions. ARE YOU FORTUNATE ENOUGH TO BE 70 1/2 YEARS OLD?

If you are at least 70 1/2 years old, you may be able to make a donation using the IRS charitable donation rollover provision. This provision of the tax law allows one to transfer up to \$100,000 annually from your IRA accounts directly to a qualified charity like KSB without first having to recognize the distribution as income. You can also name your charity as a beneficiary to your IRA.

Such donations must be sent directly from your IRA trustee to the charitable organization. We are not providing any tax advice so if you are interested in this option, be certain you work with your financial advisor.



IN MEMORY OF DENA GREENWOOD

Dena Greenwood passed away on June 11. Dena was a lovely, soft spoken woman who nevertheless was an outstanding public speaker. Combining that speaking skill with her extensive knowledge about birds made her very popular as a presenter. Frequently KSB asked her to make a presentation about some aspect of birding at our monthly Preserving the WonderTM Speaker Series. She always attracted an overflow crowd, with standing room only for those who didn't arrive early.

KBS board member Dave Norton remembers Dena from her bird walks. "For many years, Dena led free bird walks all over the Verde Valley and beyond, from Mingus Mountain to Flagstaff. I went on many and I was her spotter because for some reason, I could find an obscure bird for her to identify, and we did find some rare ones. There was quite a group that rotated in and out of her Wednesday bird walks."

"Dena was a very special person who touched the lives of many." When Joanne Kendrick first met Dena, she "was instantly drawn to her sweet spirit. Dena opened my eyes and ears to better understand and appreciate birds. I loved to hear her talk in her sweet, soft voice about

Her gentle smile and manner allowed one to ask any question, no matter how trivial. She presented several times as well as being the keynote speaker in 2016 explaining the Ecological Interrelationships between Insects and Birds in Your Garden. Through Jay's Bird Barn, she supported the NPW Silent Auction and donated little treasures for the 'swag bags' such as wildflower seeds, nesting balls and suet feeders. She was eager to help in any way she could, whether by supplying books or setting up displays. Dena was there to support and share her knowledge."

Her expertise and passion about birds gave everyone a greater understanding and appreciation for our feathered friends. She was a treasure who will be sorely missed.

A celebration of Dena's life will be held on Friday, June 22 at 11:00 a.m. at the Church of Jesus Christ of Latter Day Saints, 160 Mormon Hill Road in Sedona. A reception with a light potluck lunch will follow the service. Please bring a dish to share if you are so inclined.

Red Rock State Park hosted a star party, which was sponsored by Keep Sedona Beautiful. The Astronomers of Verde Valley (AVV) had their telescopes ready for attendees to view the heavens.

J.D. Maddy of AVV gave an interesting astronomy presentation, followed by telescope viewing of galaxies and the galaxy-rich constellations of Leo and Virgo. Under the dark skies of the park, the summer Milky Way was starting to make its way across the night sky. The planet Jupiter was high in the sky as it goes through the constellation of Libra. Venus was glimpsed low on the western horizon as it hovered in the constellation of Gemini. The easily recognizable constellations of Ursa Major, the Big Dipper, and Ursa Minor, the Little Dipper, were riding high in the northern sky. The first globular clusters of the summer made their first appearances.

The Keep Sedona Beautiful Dark-Sky Committee and the Big Park/Village of Oak Creek Dark-Sky Committee distributed dark-

sky literature and talked with the attendees about light pollution, dark-sky compliant lighting fixtures, the importance of keeping our night skies dark, and advised the attendees which communities in Arizona are International Dark-Sky Communities (IDSC), and what it means to be an IDSC. Light refreshments were provided.


